# Adopted Minutes

**November 30, 2017, 3:00 – 4:30 p.m.** Room 3134 with Polycom to N3213

- 1. Approval of Agenda Motion by T. Rector-C. Second by S. Gossard. Motion approved unanimously.
- 2. Jessica Ulstad, CFT: Update on Statewide Political Opportunities (COPE committee work). Jessica is the Political field director. She works will local unions on COPE fundraising and BOT races, manages field work for propositions, like Prop. 30 and coordinates efforts with other locals.

The Janis supreme court case seeks to eliminate non-member representation fees (agency fees); however the union would still be required to represent non-members. It is expected not to be decided in our favor. The ruling will only effect public sector unions. CFT expects that locals will lose about 11% of revenue.

It is important that in anticipation of this ruling, CCFT have copies of membership forms for all of its members.

The agency fee has only been around for 30 years. We can be successful without it but we will need to reach out more to members to ensure they understand the value of their membership.

Any raise in CFT/AFT agency fees will be discussed/approved at the CFT convention.

- 3. Negotiations and Impasse Update Fact-Finding Status and Work to Contract Campaign
  - Article 4 Across the board on-schedule salary request for 2016-17 is 2.5% Increase in PT faculty office hours to 30 minutes for each 20% of load (cost is about 0.75% of total salary plus state provided more funding)
  - Article 5 Loading of faculty to allow flexibility in scheduling until 2 weeks before class begins
    Language expanding use of FT Temp positions
    Conflict in terminology about Chair elections
    Systematic terminology
  - Article 7 Request to change language to keep retirees on same cycle Julie is collecting requested edits to peer evaluation forms
