- 1. Approval of agenda. The agenda and minutes were unable to be approved due to lack of quorum.
- 2. Approval of minutes from the 2/25/2016 council meeting.

Comments regarding 2/25/ minutes:

RE: number 7: D. Stakes wants it noted the CCFT did propose an additional 1% on salary increase for part time faculty but the district failed to accept the proposal.

RE number 4: Biology department wants it noted that on a 16 week schedule, biology would lose not only 1 lab but 2 to 4 labs, and also 2 solid weeks of audio tutorial lab.

- 3. Benefits: New SISC rates Frank
- D. Gough, a benefits committee member commented that the new rates don't seem too bad. He and F. Ha recommend that we keep same plans unless there were complaints. Rates will go up between \$27 and \$75 (4.8% to 5.2%) a month. He also noted that SISC has a new service called Grand Rounds. They help you find a doctor if you are new to the area and also help you get a second opinion for existing conditions.
- D. stakes requested that they send out the rates to the membership.
- 4. Summary of State Convention Debra D. Stakes commented that there were great presentations. As soon as they are available on-line we will link them from our website. CFT has a

community college council which is making statewide effort to change the Ed. Code to provide for job security (seniority and bumping rights) for part-time faculty. The bill is AB 1690 (see more below).

5. Contract Revisions, TA, & Mediation update – Debra

Mediation lasted 9 hours on Tuesday. We had a list of tweaks we wanted to articles 5 and 7. They did not agree to part-time bumping or the 150% overload cap for large lecture. We included program review etc. as documented responsibilities for full-time faculty.

All of articles 4, 6, and 10 are posted in redline version on the website. Without mutual agreement, all articles have to go to ratification at the same time, and the District insists that this be the case.

The council discussed if we should go to impasse over the holdouts listed above. There are pros and cons to going each way. Those present thought the EB should not hold up the vote based on the issues above. The EB needs to make a vote to determine if the TA goes to a vote before the membership.

6. AB 1690 – Debra

Resolution to Improve Student Success and Retention by providing a more stable Temporary Part-Time Faculty Workforce.

Proposed by Jose Medina. There is a statement of support that D. Stakes is going to try to get our BOT to approve. There is also a draft of a letter to the governor that individuals can send out.
