- 1. Approval of April 2, 2015 EB Meeting Minutes deferred until next August (no meeting on 16 April)
- 2. Interview of two PT Chair candidates for Chair of PT committee on Executive Board Interviewed Nancy Steinmaus from Kinesiology and Steve Hendricks from Biology

Although both candidates were enthusiastic knowledgeable and articulate, the Board decided to offer the position to Steve Hendricks. This will begin next academic year

3. Senate Update

Next month is the last meeting of the academic year and Kevin's last meeting as President. Lara Baxley will take over as Senate President. Katie Niedhart will take over as V.P. Cherie Moore will remain as Curriculum Chair. Kevin says that the Senate appreciates opportunity to work with Union on issues of common interest. The Division Chair job description will go to the Senator for feedback. The updated job description is based on what the chairs are actually doing.

4. Discussion of email and communication issues

How to preserve individual freedom but represent CCFT professionally

Need to collaborate with Senate on policy

There were no proposals brought forward to modify or replace current electronic communication use policy. Concern about misinformation being disseminated.

There are legislative efforts to increase job security for PT faculty, including money targeted for converting PT to FT positions and new rules imposing a seniority system for PT faculty

7. Treasurer report

Bank Balances are CCFT \$72,863.86; COPE \$3197.50 with \$2552 set aside for BOT leaving \$644.50 as discretionary.
