Pending CCFT Ratification and Board of Trustees Approval

The San Luis Obispo County Community College District and the Cuesta College Federation of Teachers have completed negotiations of Article 5.8.1, Lab Loading for the 2023-2024 and 2024-2025 academic years. This article will be amended as follows:

The following is effective Spring 2024:

5.8.1 The full-time load of a regular instructional faculty member (including Non-credit Enhanced ESL) is based on 15 lecture hours or **18** laboratory hours or a combination of lecture and laboratory hours. One lecture hour equals six and sixty-six one hundredths percent (6.6666%) of a load; one laboratory hour equals five and fifty-five one hundredths percent (**5.5556%**) of a load.
